

Childline Breakfast iPad Giveaway – Terms & Conditions

1. Promoter

The promoter of this giveaway is the ISPCC (Irish Society for the Prevention of Cruelty to Children)

2. Eligibility

- Open to preschools, crèches, primary schools, secondary schools and other educational or childcare settings located in Ireland.
- Staff members submitting entries must be aged 18 or over.
- Only Childline Breakfast events registered and held as part of the 2026 Childline Breakfast campaign are eligible.
- No purchase or donation is necessary to enter.

3. How to Enter

To enter the draw, participants must:

- Host a Childline Breakfast event during the campaign period; **and**
- Share at least one photo of their breakfast celebration by either:
 - Emailing it to **breakfast@ispcc.ie**, or
 - Tagging **@childlinebyispcc** on Instagram in a public post or story.

Each participating setting may submit multiple photos, but **only one entry per setting** will be counted.

4. Entry Period

- Entries open on the official launch date of the Childline Breakfast campaign.
- Entries close at 11:59pm on the 31st May 2026.
- Entries received after the closing date will not be included in the draw.

5. Prize

- Winners will receive **one (1) Apple iPad**, kindly donated by Vodafone and Tozi.
- The prize is non-transferable, non-exchangeable, and no cash alternative is available.
- The ISPCC reserves the right to substitute a prize of equal or greater value if necessary.

6. Winner Selection

- The winner will be chosen at random from all eligible entries.
- The draw will take place within 7 days of the campaign closing.
- The winner will be contacted via the email address used to submit the entry or via Instagram direct message if the entry was submitted through tagging.
- If the winner does not respond within 7 days, the ISPCC reserves the right to select an alternative winner.

By submitting photos via email or Instagram:

- Participants grant the ISPCC permission to use the images for promotional purposes related to the Childline Breakfast campaign, including social media, website, and printed materials.
- Participants confirm they have obtained consent from all individuals featured in the photos, including parental/guardian consent for any children.

- Contact details will not be shared with third parties except where required to deliver the prize.
